Subject: Establishment of a new subsidiary for business collaboration with strategic investors

To: Director and President, Stock Exchange of Thailand

MFEC Public Company Limited (“the Company” or “MFEC”) would like to notify that the Board of Directors' Meeting No. 1/2026 of Venture Lab Company Limited (“Venture Lab”), a wholly-owned subsidiary of the Company, held on 23 January 2026, resolved to approve the establishment of a new subsidiary through the spin-off of the business relating to market research services, consumer data collection, and comprehensive in-depth data analytics for private sector businesses and organizations, which had previously operated under Venture Lab. The purpose of spin-off is to conduct the business through a joint investment with strategic investors, in alignment with the resolution proposed and approved by the Company's Board of Directors' Meeting No. 1/2026 held on 23 January 2026. The preliminary details of the newly established subsidiary are as follows:



Business objective and nature of business	To engage in the business of providing market research services, consumer data collection, and comprehensive in-depth data analysis to private sector businesses and organizations. This encompasses services delivered through consumer panel platforms, quantitative and qualitative research, data analysis utilizing technology and digital tools, as well as consulting services in marketing strategy, branding, and business strategy based on in-depth insights.
Expected Transaction Completion Date	The new subsidiary is expected to be registered and incorporated in February 2026. The strategic investor is expected to complete the investment within the second quarter of 2026.


The investment transaction in the aforementioned subsidiary will result in the Company indirectly holding shares through Venture Lab Company Limited, whereby the newly incorporation of the entity will classify as a subsidiary of the Group company. Crowdabout has plan to raise capital from external strategic investors who are not related to the Group, with the objective of strengthen business capabilities and expanding business opportunities to generate long-term profitability. Such investment participating by the strategic investors will result in the Group's shareholding proportion reduce from 75%to 63.75%. Nevertheless, Crowdabout will continue to be under control by the Group's management team and will maintain its status as a subsidiary of the Group, both before and after the capital raising from the strategic investors.
